**Supplemental Life Insurance**

You can purchase Supplemental Life Insurance in increments of 1 times your annual Earnings up to 2 times your annual Earnings, rounded to the next higher \$1,000. The maximum amount you can purchase cannot be more than 2 times your annual Earnings or \$600,000. If you elect an amount that exceeds the guaranteed issue amount of \$300,000, you will need to provide evidence of good health that is satisfactory to The Hartford before the excess can become effective.

**Spouse Supplemental Life Insurance**

If you purchase Supplemental Life Insurance, you can purchase Spouse Supplemental Life Insurance in increments of \$5,000. The maximum amount you can purchase cannot be more than the lesser of \$300,000 or 100% of your combined Employee Basic and Voluntary/Supplemental Life Insurance coverage. If you elect an amount that exceeds the guaranteed issue amount of \$50,000, your Spouse will need to provide evidence of good health that is satisfactory to The Hartford before the excess can become effective.
